# Programmer's Corner

Like many of you, we have spent this summer waiting on HUD to release the new HUD-50058 sub-module. As of today, we don't know when HUD plans to move forward with the implementation. I keep checking the form-50058 page to see if there is any new information under quick update. Here is the address to that web page <a href="http://www.hud.gov/offices/pih/systems/pic/50058/">http://www.hud.gov/offices/pih/systems/pic/50058/</a>. As soon as we hear something, we will send e-mail to all of you that are registered for our e-mail service.

While we have been waiting on HUD, your development staff has been busy here completing user program change requests. We have completed 106 changes since the last update was mailed. During this month, we should begin the process of sending out the V4.8 software release. You will be notified as soon as it is ready.

You should have already received a letter advising you that SACS is changing development systems. We have entered into an agreement with AcuCorp, the makers of AcuCobol, to provide our development system and runtimes. I believe that AcuCorp's development tools will allow us to develop a windows based GUI application much faster and easier. It will also allow us to use features that were not available with RMCobol. AcuCorp has been providing development software for over 13 years.

We have converted the SACS Housing Software programs to AcuCobol and are now testing them for proper operation. Our in-house accounting staff are using the new programs now and have not had any problems. You will be receiving another letter from SACS in the coming weeks outlining the steps that are required for conversion. It will take us a couple of months to migrate all of our users to this new system.

One of the features, that this new development system gave us, is the ability to accept responses in upper or lower case. The V4.8 AcuCobol programs will allow the operator to enter "ADD" or "add" when prompted for function. At the same time, use "YES" or "yes" to answer the data ok prompts. This tends to make life easier for everyone.

There are other enhancements, that we will be using in future updates. For right now we are going to make the transition easy, so the programs will look and feel like they have in the past. My development staff and I like this new system and see it as a way to move SACS Housing Software into the future.

# **Technical Support**

On a day-to-day basis, we receive a large number of calls about printers not working. Before calling, please check the following, they may fix your problem: make sure that the printer is on-line or selected, is an adequate supply of paper installed, does the ribbon or toner cartridge need replacing. If you call for support, make sure to tell the technician about any flashing lights on the front of the printer control panel.

It is a good idea to follow the checklists provided with the software. These are updated with each software release and can be printed by pressing the F9 key from any SACS menu screen. When you call for support, we may ask you what step in the processing sequence, that you are having trouble with. It will assist the support staff if you can provide this information.

Many of you are upgrading your computer systems to the latest technology. Please remember that you need to make sure that SACS can dial into the machine that has the tape drive. This will give our support technicians the ability to assist you with restores.

As a reminder to everyone, you should be doing a backup daily, one day per tape. We also recommend that you make another backup at the end of the month on a different tape.
